### Household Hazardous Waste Drop-Off Event

Saturday, December 13, 2025 from 8:00am to noon Residents are encouraged to take advantage of the upcoming Household Hazardous Waste Drop-Off event. The event will be held at the Cypress Civic Center, located at 5275 Orange Ave., Cypress. This is a convenient opportunity to safely dispose of items such as paints, chemicals, batteries, electronic waste, and other hazardous materials that should not be placed in regular trash bins. Proper disposal helps protect our environment and keeps our community safe.

#### CHRISTMAS TREE DISPOSAL

During the Tree Sweep from **December 26 to January 16**, Cypress residents can easily dispose their holiday trees. Trees 5 feet and under may be placed inside the dumpster, while trees larger than 5 feet should be placed outside the dumpster the night before your scheduled trash pickup day.

Before placing your tree out, be sure to:

- Remove all decorations, including lights, ornaments, tinsel, garland, and the stand.
- Cut the tree into sections no longer than six feet for safe pick up.
